O lenei Lipoti Fa'aletausaga 2019-2020 a le Matagaluega o Fesoota'iga ma Fa'amatalaga Tekonolosi (Ministry of Communications and Information Technology), ua tapenaina mo le silafia e ana pa'aga uma le fa'agasologa ma le taunu'uga o galuega fa'atino, e tusa o fuafa'atatau mo galuega fa'atino (Key Performance Indicators) sa fuafuaina ma fa'ataoto i totonu o le Tala Fa'atatau Autu o Tupe.

O lenei Lipoti ua vaevaeina ini Vaega se Tolu (3):

VAEGA A ua fa'amatala manino atu ai i lona aotelega ta'iala fa'aletulafono a le Matagaluega, o ana matafaioi ma nafa tauave, o lana pulega, fa'atasi ai ma le auivi o galuega, fetuuna'iga o le Aufaigaluega. O lo'o aofia foi i le vaega lenei o le Lipoti se va'aiga lautele i galuega sa fuafuaina e fua i fuafa'atatau mo galuega fa'atino, e pei ona fa'ataoto i totonu o le Tala Fa'atatau Autu o Tupe mo le tausaga fa'aletupe 2019-2020.

VAEGA E ua fa'amatala 'auiliili atu ai le tulaga ua iai le fa'atinoga o galuega sa fuafuaina i totonu o le tausaga fa'aletupe 2019-2020. O lo'o ua fa'amauina foi nisi o matati'a ma galuega ua ausia, fa'atasi ai ma lu'itau mo le agai atu i le lumanai.

VAEGA I ua 'auiliili atu ai le fa'aaogaina o vaegatupe i Vaega Ta'itasi a le Matagaluega mo le Tausaga Fa'aletupe 2019-2020.



E ia te a'u le ava ma le fa'aaloalo tele, oute tu'uina atu ai le Lipoti Fa'a-le-tausaga lenei a le Matagaluega o Fesoota'iga ma Fa'amatalaga Tekonolosi mo le tausaga Fa'aletupe 2019-2020.

O si o tatou Atunu'u o Samoa, e ui ina laititi, va'api'api ona puna'oa ma oloa auina atu i fafo, feagai pea ma lu'itau i fesuia'iga o le tau, a'afia gofie i fa'afitauli o le tamaoiga o le lalolagi, fa'atasi ai ma lona tulaga mamao ese mai Malo tetele, fa'apea le fa'alagolago pea i le tele o tupe fa'amomoli mai fafo, peita'i, a tatou toe tepa i le sefulu tausaga ua mavae, ona o tatou maofa lea i le tele o suiga talafeagai, taua ma le lelei tau fesoota'iga ma fa'amatalaga tekonolosi ua iai nei; e le gata i avanoa mo *auaunaga fa'atekonolosi fou ua ofi mai*, o *pisinisi ma atina'e fou tau fesoota'iga*, a'o sailiiliga foi mo *tomai ma metotia fou fa'atekonolosi*, ua le gata i totonu o le Malo, Kamupani ma Pisinisi, ae fa'apea le Atunu'u lautele i ona vaega eseese.

O le sologa lelei ma le manuia pea o galuega ma atina'e tau fesoota'iga a le Lala Maoti o Fesoota'iga ma ana Pa'aga, ona o le fa'ataua ma le fa'amamafa a le Malo i atina'e ma polokalame tau fesoota'iga ma fa'amatalaga tekonolosi i Samoa. E fa'amautu lea mau, ona o lo'o atagia i totonu o le Ta'iala mo le Atina'e o Samoa 2016/17 - 2019/20 (Strategy for the Development of Samoa 2016/17 - 2019/20), i lana Va'aiga Taula'i, e unaia atina'e ma fa'atupula'ia avanoa mo tagata uma. I le Vaega Fa'amamafa 3 o Atina'e Tetele, i lona Taunu'uga Moomia 11, o lo'o fa'aupuina e fa'apea, *Auaunaga mo Fesoota'iga fa'atuatua ma fa'amoemoeina*. O ina o lo'o taoto ai le tele o galuega sa fa'atinoina e le Malo, ina ia si'itia maua le tulaga o fesoota'iga, fa'atuatua ma fa'amoemoeina, taugofie ma maua e tagata uma o Samoa. O le tausaga e 2017 na fa'alauiloa ai foi le ulua'i Fuafuaga Alualu Mamao a le Lala Maoti o Fesoota'iga 2017/18 - 2021/2022 (Communications Sector Plan 2017/18 - 2021/22), o loo ta'ialaina uma ai galuega ma atina'e a lenei Lala Maoti, i lana va'aiga taula'i e fa'apea, *"Ia taugofie ma talafeagai fesoota'iga ma auala fa'atekonolosi mot agata uma"*. O nei fuafuaga ma ta'iala uma a le Malo ma le Lala Maoti, o loo lima ta'ita'ina ai lenei Lala Maoti, Kamupani ma Pisinisi ma ana Pa'aga uma, i le una'ia ma le fa'atinoina o galuega silisili ma le ānoa, e ausia ai isi Ta'iala fa'avaomalo, e pei o le Fuafuaga a Malo Aufaatasi 2030 (Sustainable Development Goal's), SAMOA Pathway, ma isi.

O se tasi o matati'a o lenei tausaga Fa'aletupe 2019-2020, o le taliaina lea ma le fa'atinoina o galuega amata mo le fa'atuina o le Pulega o Auaunaga Fa'atekonolosi (Digital Transformation Authority), ma le Vaega Fa'apitoa e mata'ituina le malupuipua o le Initaneti (Samoa Computer Emergency Response Team) mo le Malo ma Samoa atoa, mai faiga fa'asolitulafono. O nei atina'e ua fa'amautuina ai le lagolagosua ma le fesoasoani

mai o a tatou Pa'aga. O nei fa'aiuga a le Malo, ua atagia ai le vilivilita'i o le Malo, ina ia taulamua pea Samoa mo so'o se atina'e tau fesoota'iga ma fa'amatalaga tekonoosi, ma le fa'atuina o se fola fou mo auaunaga fou fa'atekonosi a le Malo ma Kamupani, e tu'uina atu i le mamalu o le Atunu'u. O le sini autu o nei fuafuaga, ina ia unai'a le galulue fa'atasi o Itutino uma o le Malo mo so'o se atina'e tau fesoota'iga, ina ia mafai ona fa'atino fa'atasi le tu'uina atu o auaunaga a le Malo e fa'aaoga ai le Initaneti, ma le ausia o lana miti, *"Samoa e ave ma ta'imua i le Atu Pasefika, i auaunaga fou tau fesoota'iga ma fa'atekonosi."*

O le fa'amoemoega maualuga o le Malo mo so'o se atina'e tau fesoota'iga, e le gata ina ia ta'imua Samoa i suiga fou ua iai nei i auaunaga fa'aneionapo, ae sili foi le taua ma le mautinoa o lo'o malupuipua, saogalemu o tatou tuaoi fa'avaomalo tau fesoota'iga, o auala o fesoota'iga fa'alotoifale, fa'apea polokalame fa'aeletoni, i le iai lea o Faiga Fa'avae ma Tulafono talafeagai i fa'amaumauga patino o tagata uma, ma osofa'iga fa'asolitulafono e fa'aaoga ai le Initaneti. I le a'afia ai o Samoa i le Fa'amai o le Misela, soso'o mai ai le Koviti-19 i lenei tausaga fa'aletupe, lea ua a'afia ai le lalolagi atoa, ua fa'amaonia ma molimauina ai le matua taua ma le aoga o atina'e ma poloketi tau fesoota'iga i le Atunu'u. O nei fa'ama'i tetele na a'afia ai si o tatou Atunuu, ua saga fa'amausali ai le taua ma le talafeagai o le una'ia pea e le Malo o atina'e tau fesoota'iga i so'o se vaega o le Atunuu, ina ia mafai ona tali atu i taimi fa'apenei, ae maise nisi fa'afitauli o mulimuli mai. O nei atina'e uma tau fesoota'iga i le Atunu'u, ua tu mati'e ai taumafaiga a Samoa fa'atusatusa i isi Atunuu o le Lalolagi.

Ina ia taunu'u ma ausia le manulauti o atina'e ua taua i luga, e tatau i le Malo ona ave pea lana fa'ataua ma lana fa'amuamua i le atina'eina o tomai ma agava'a fou ua moomia mo auaunaga tau fesoota'iga, e ala lea i le una'ia pea ina ia maua auala o fesoota'iga e gafataulimaina, o le tasi lea auala. Fa'atasi ai ma le taua o le galulue so'oso'o tauau o le Matagaluega i lana Vaega o Faiga Fa'avae, ma isi Lala Maoti o le Malo, Kamupani ma le Atunu'u atoa, ina ia silasila toto'a i vaega taua o nei fesoota'iga uma, e taua ma a'anoa mo le atina'e o Samoa.

I lo'u valaauina o le Minisita o Fesoota'iga ma Fa'amatalaga Tekonoosi, oute toe fa'ailoa atu ai le taua o so'otaga o atina'e ma galuega uma a lenei Matagaluega ma le Lala Maoti o Fesoota'iga, i fuafuaga alualu mamao ma ta'iala o atina'e a lo tatou Malo. Ua silafia e le Malo ma si o tatou Atunu'u, le taua o le fa'aaogaina tatau o fesoota'iga ma fa'amatalaga tekonoosi, mo le una'ia ma le si'itia o lo tatou tamaoiga, fa'atasi ai ma le una'ia o Kamupani ma Pisinisi i le fa'aaogaina o tekonoosi fou, fa'atupulaia avanoa faigaluega, ma ia mafai ona fa'atauvā ma isi i fafo atu o Samoa. I lenei tausaga Fa'aletupe, sa galulue punoua'i le Matagaluega ina ia una'ia le Malo, e fa'atino nisi o atina'e e mautu ma mautinoa, o se fola mo se amataga fou o ana auaunaga fa'atekonosi, e le gata i le fa'aaogaina o metotia fou fa'aneionapo, ae maise o nisi o auala fou e mautinoa e anoa ma si'itia ai le soifuaga o Aso uma o nai o tatou tagata, mo nei ma iē lūā.

E avea ai lenei avanoa e fa'aleo ai fo'i le fa'afetai i le lagolagosua mai a Pa'aga uma a lenei Lala Maoti o Fesoota'iga, le Matagaluega ma a matou Pa'aga mai fafo, ina ua mafai ona taunu'u i le manuia galuega o lenei Tausaga Fa'aletupe. O se vaitau faigata, e ui ina lataluta ma souā le tatou savaliga, a'o lenei ua tuta i Nu'u manaia ma ua a'e i fanua le fa'atamasoāli'iga. Tatou tulimata'i se amataga fou i tausaga o mulimuli mai, a'o tumau pea lo tatou galulue feoeoea'i.

O le Matagaluega o Fesoota'iga ma Fa'amatalaga Tekonolosi, o le faufautua fa'alefaiga fa'avae lea i le Malo mo mataupu tau i fesoota'iga ma atina'e eseese fa'atekonolosi. I lenei Tausaga Fa'aletupe 2019-2020, sa mautinoa le fa'aauau pea ona taimu'a lenei Matagaluega i le tu'uina atu o fautuaga fa'alefaiga fa'avae i Matagaluega uma a le Malo ma ana Pa'aga i mataupu uma tau Fesoota'iga ma Fa'amatalaga Tekonolosi.

E tele ma anoanoa'i ni matati'a sa mafai ona ausia e le Matagaluega ona o le fesoasoani ma le lagolagosua mai o a matou Pa'aga. I lenei tausaga fa'aletupe 2019-2020, sa sosolo lava le fa'atinoga o galuega ma auaunaga a le Matagaluega i Fuafuaga ma Ta'iala a lo tatou Malo.

O galuega fa'atino a le Matagaluega o loo limata'ita'ina lava i le Ta'iala mo le Atina'e o Samoa 2016/17-2019/20 (Strategy for the Development of Samoa 2016/17 - 2019/20) ma le Fuafuaga Alualu Mamao a le Lala Maoti o Fesoota'iga 2017/18 - 2021/22 (Communications Sector Plan (CSP) 2017/18 - 2021/22).

Ua 'oto'oto atu i lalo nisi o galuega ua mafai ona ausia e le Matagaluega, i lalo o le ta'itai'ga a le Afioga i le Minisita o Fesoota'iga ma Fa'amatalaga Tekonolosi mo lenei Tausaga Fa'aletupe:

1. 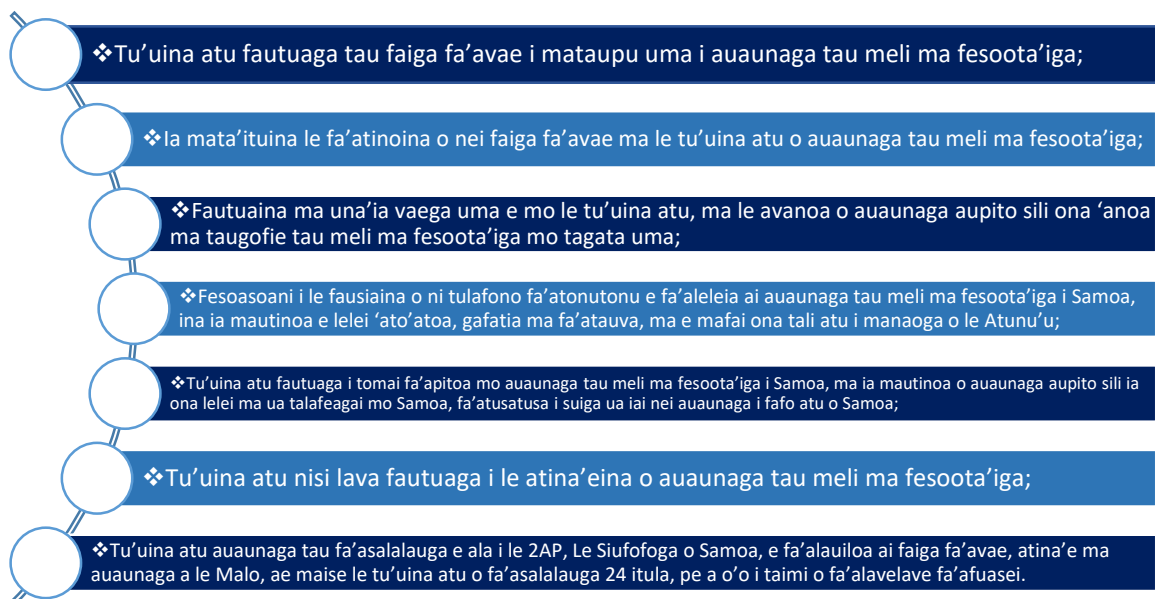

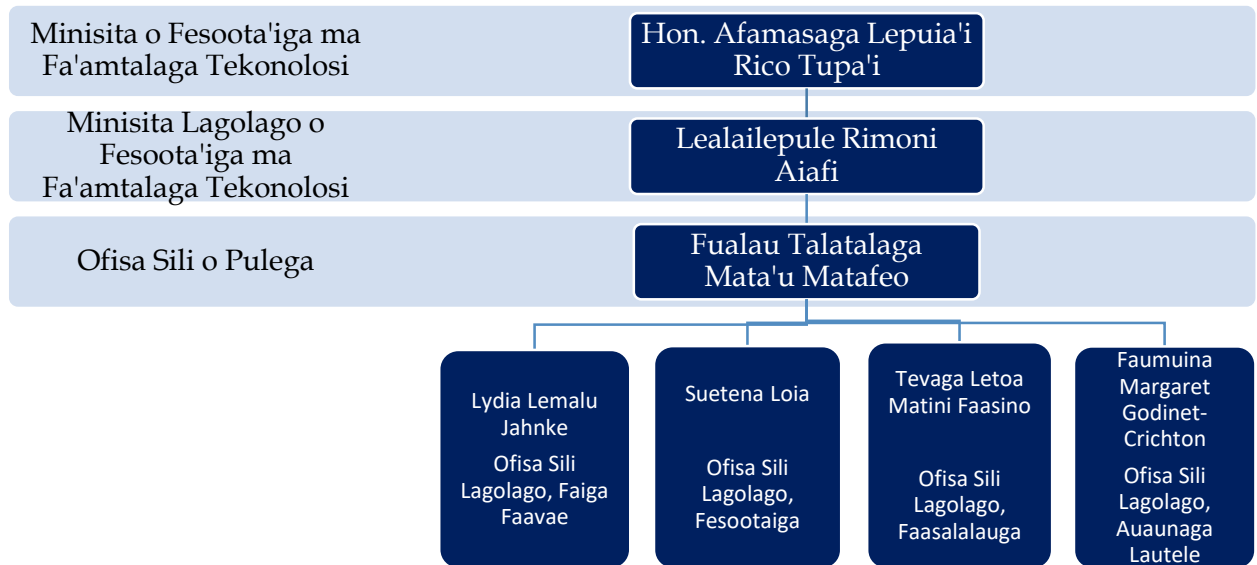

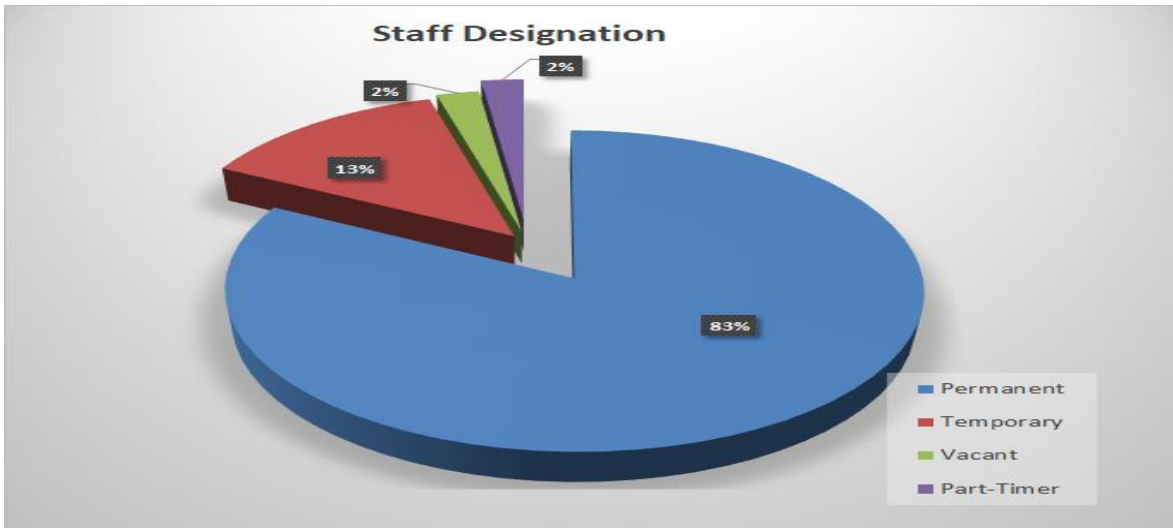
